1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Solapur, a *multi-lingual city*, is located in the South Eastern region of Maharashtra. Solapur district, a multicultural hub, shares its borders with the states of Karnataka and Telangana. People here speak vernacular languages like *Marathi, Hindi, Telugu, Urdu and Kannada*. Solapur city was once famous for its textile mills and handloom industries. However due to the shutting down of various Mills a major section of the population came under the grip of intense poverty. To make matters worse, the pandemic left no stone unturned in causing more physical problems and mental trauma. A major section of the people in Solapur district belong to the economically lower Strata of the society and struggle hard to make a living for themselves. But the diehard spirit of the people, not willing to accept defeat, is rising up once again through its own ashes like the proverbial bird Phoenix and emerging successful..... The flight has Begun.

This is because people have realized that there is no substitute for knowledge and the significance of education. There are a number of institutions in Solapur district imparting diverse education and academic facilities to students.

Padmashali Shikshan Sanstha, established in the year **1912**, is one of the oldest educational institutions which caters to the academic needs of the underprivileged students coming from the Padmashali community. The Management runs 24 educational institutions which includes *primary schools, high schools, junior colleges, technical college, night college and a womens' senior college.*

A. R. Burla Mahila Mahavidyalaya was established in the year **1990** with the **Arts and Commerce faculty**. Having faced a number of obstacles and challenges in the form of infrastructure, students strength, financial aid and much more we succeeded in creating a name for ourselves under the banner of **Punyashlok Ahilyadevi Holkar, Solapur university, Solapur.**

Having traversed these 32 years with determination and dedication we have successfully started with *a* **Research Place in Commerce, BCA faculty,** and have increased the number of students in a commendable manner.

Most of our girls are first generation learners with not a single member in their families having ever entered the portals of a college. Our college chiefly aims at equipping the girls academically so that they do not fall short of facing challenges. We are here to help our students materialize their dreams, fulfill all their aspirations, equip them with the Armour of education and help them develop in a Holistic manner.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Institutional goals and objectives are well integrated with the academic programs. We plan and execute the curriculum effectively.

Our students are on the merit list of the university and the overall passing percentage is excellent. We have the maximum number of Representation to the university in the form of *Members (Senate), Members (Academic Council), Chairperson and members (Board of Studies), Chairperson and Members (Syllabus Sub Committee), Chairperson and Members of CRC, Chairperson (Lapses Committee), Members (Local Inquiry Committee), Members (Department of Research Committee), Member (Board of Sports) etc.*

This gives ample of opportunities in contributing towards the design and development of the university curriculum. Direct role is played in designing and updating the curriculum. Sharing of inputs and suggestions regarding the curriculum and an active participation in the same is done on a regular basis. Our faculty has contributed towards the designing and editing of textbooks. Some of the books written and edited by our faculty are being used as reference books by our university and other universities too. Some of them have even contributed chapters towards text books and reference books of our university and other universities. Our faculty have contributed in the design and development of the curriculum for the in-house career-oriented certificate courses in consultation with experts from the respective fields.

Regular feedback is obtained from students, teachers, parents and stakeholders. These suggestions are utilized at the time of syllabus framing and restructuring of the same. The feedback is analyzed and the needed action taken. Any steps or measures taken are always student centric methods and aimed at improving their performance. *College takes initiative in organizing workshops for the benefit of the teachers and students.* Faculty offer their services as resource persons at workshops, seminars and conferences.

We upgrade our teaching methods and try to bring about a lot of innovation in the *teaching- learning process*.

We have a **Memorandum of Understanding** with a number of academic and non-academic institutes and the collaborative activities with these different Institutions give our students the much-needed impetus and exposure. We have as many as *37 committees* in the college which cater to the curricular, co-curricular and

extracurricular activities and development of our students. We conduct remedial and enrichment programs for the slow and advanced learners. For proper planning and implementation, we prepare the academic calendar, timetable and the annual teaching plan even before the commencement of the academic year. The **Mentor** - **Mentee** scheme helps in monitoring the progress and other issues of the students on a regular basis. We frequently arrange expert lectures, competitions, seminars and conferences with the view to upgrade our students. Our focus is on empowering the girls through quality education. We focus on imparting value-based education and installing morals and ethics within our students.

Teaching-learning and Evaluation

We identify slow and advanced learners. **Remedial and Enrichment programs** are organized to help them out.Certificate courses are conducted for the students keeping in view the global scenario. *Links of teacher's videos, other relevant videos/ audios, ppts and other study materials are provided to the students*. Films based on the syllabus are screened. Expert lectures are arranged. Students are encouraged to take up project work so as to have a broader idea of the subject.

As a process of the evaluation method *home assignments, tutorials, unit tests, open book test, revision tests, MCQ tests are conducted.* Question banks are provided to the students. They are also encouraged and helped to solve question papers. Students are also encouraged to attend lecture series by experts are online and offline. The mentor mentee scheme is greatly beneficial as it helps in monitoring the progress of the students and likewise helps to guide them. The Continuous Internal Evaluation committee of the college is monitored by the examination committee. The committee executes all the activities related to examination and assessment in a very appropriate manner.

Maximum opportunities are given to the faculty to update themselves by attending seminars, workshops, refresher/ orientation programs, faculty development program, conferences etc. We have a fully qualified faculty with *NET/SLET*. 14 out of 16 full time teachers have **Ph. D** as their highest qualification, while 1 has **M. Phil as** her highest qualification.

Research, Innovations and Extension

Research is an integral part of our college. We have a research place in Commerce. Research oriented activities are conducted and students are encouraged to participate in the same. Students are also encouraged to attend workshops and present papers. We are very happy to state that many of our students have won prizes at the research paper presentation competition. Every year our students participate in the **Avishkar Research Competition** organized by the University. Our students have represented the college at the University and State levels and have been awarded prizes.

Research forms of vital part in the academic life of our faculty. *Earlier eight minor research projects* were completed by our faculty. During the last five years one major research project was taken up by the faculty.

Faculty members have also written chapters in textbooks prescribed by *Mumbai University, Bharati Vidyapeeth, Pune and P. A. H. Solapur University Solapur*. The faculty members have also been resource persons at Refresher Courses and Seminars/Workshops organized by a number of universities/ colleges.

Our college organize a number of National/State/ University level Seminars and Workshops for the benefit of teachers and students. Every year we organize a workshop on Intellectual Property Rights. This year we organized a 30-day workshop on Research Methodology for all the research scholars of our university.

We have 11 research guide from among our faculty. So far 13 scholars have completed Ph. D during the last five years and 37 have registered for Ph. D under the able guidance of our faculty.

A spirit of enquiry and curiosity is ignited among the students by encouraging them to undertake project work and survey. Our college has signed Memorandum of Understanding with a number of academic and nonacademic institutions. Collaborative activities, programs, lectures are all arranged with the idea of giving the best to our students.

- The total constructed area is 2846 sq. mts
- We have a well-furnished Principal's cabin and self-sufficient administrative office.

- There are 12 number of classrooms, one seminar hall, one computer lab, a well-equipped *library, Gymnasium cum the cabin of the Director of Physical Education, the NSS room cum Health Centre.*

- There are sufficient washrooms with the needed facilities. There are facilities like ramp and a wheelchair for the physically challenged students.

- We have a small canteen with basic provisions for the students. In fact, our students are encouraged to get their tiffins so that they eat healthy.

- We have sufficient parking space for the faculty and students.

- *Water purifier with cooler* has been installed so that we get clean purified water.
- *CCTV* cameras have been set up at Prime points to monitor all activities taking place within the college campus.
- We also have proper security within and around the campus as we have full time watchman.
- The library is housed with a total of **17135 books**.
- We subscribe to **21 journals.**
- We have a software purchased for maintaining students' data.
- The **LIBMAN software** is used in the library.
- *E- resources* are offered through the **INFLIBNET**.
- The library of first internet connection with Wi-Fi facility to the staff and students.
- In addition to this, we have the **Departmental Libraries** and the **Book Bank Scheme**.

Student Support and Progression

We have a counselling department which not only supports but also counsels the students regarding academics,

career, emotional well-being and health/ hygiene. The students' progress is monitored through the mentor - mentee scheme. Economic aid is provided a few selected students deprived even of the basic amenities of life. A number of Sponsored cash prizes are given to the meritorious students in academics, sports and cultural activities. The **Anusayabai Dattak Yojana** sponsored by the faculty members, a fixed deposit of **Rs 40000**/, books donated to the library by the faculty, calculators donated by our faculty and the philanthropic work by our staff members help towards the support and progression of our students. The competitive guidance Centre create awareness among the students regarding competitive exams and placement. The career guidance cell also organizes a number of lectures for the benefit of the students. Initiative for capacity building is done through skill enhancement programs and certificate courses, *focus is given on Language and Communication Skills, 21st Century Skills, Information and Communication Technology, Computing skills etc.*

Expert lectures on various issues and trends are organized all-round the year. Doctors, advocates, bank officers, professors, entrepreneur, government offices and motivational speakers are invited as resource persons to speak on relevant topics. The certificate courses conducted in the College help the students to get jobs. **Remedial and Enrichment coaching** is done for the benefit of the students. *We organize workshops on yoga, meditation, art of Living, stress free living etc.* We have a transparent mechanism for student's grievances with timely redressal for the same.

Progression towards higher education is increasing which is something very encouraging. Ample opportunities are provided to students to showcase their skills and talents. We have published a Handbook on the 'Code of Conduct' for the *students, teachers, administrative staff etc.* We have a number of activities which help in the holistic development of the students.

The Career Katta counsels the students about job opportunities.

Governance, Leadership and Management

We have a transparent governance which is both democratic and decentralized. The institution adheres to Government and UGC norms/ rules. We have a vision, mission and well-defined objectives. This is communicated to *students, parents, and stakeholders through the website, prospectus, the display board and various other activities*.

The college development committee uses its expertise and makes strategic plans which is well executed. We face the University Academic and Administrative Audit every 3 years. In addition to this, we have the

internal Academic and Administration audit every year. We are happy to state that we have always secured an **'Excellent'** grade.

The IQAC works relentlessly and takes the initiative to organize quality programs.

The college participates in the **NIRF** and also sends the institutional data to **AISH every year**. The college has the **ISO Certification** and works towards quality enhancement.

3. THE CONTEXT:

Our college caters to the academic needs of the girl students, specially those belonging to the Padmashali Community and the economically disadvantage strata of the society.

Most of our students are not aware of the importance of sports and games, the purpose of participating in sports, the benefits one can get from it.

Ironically, most of our students have never participated in any games. A few others who have played school/ Jr. College level are not even aware of the rules and regulations of the same. Coming from basically orthodox families, these girls have not even worn sports dress and hesitate from wearing the same. A few parents do not even permit their wards for practice sessions/ participation.

4. THE PRACTICE:

At the beginning of each academic year, our Director of Physical Education personally talks to the students regarding the importance of sports and games. A lot of motivation is done in addition to informing the students about the various benefits, job opportunities etc. Very often the students are interested but their parents do not permit them for the same. It is a difficult task convincing the students and getting permission from the parents.

5. PROCEDURE:

The students are allowed to choose any sports as per their preference. Proper coaching is given through different coaches. During the training sessions, the student's skills, physical ability, agility, aptitude for the game etc. are tested and further decisions are made. Counseling is done on a regular basis. Practice sessions are conducted in the morning and evening.

- Upliftment of people's mood due to exposure of living in a better environment
- We receive a lot of cooperation from the villagers
- During our residential camps, they provide us with vegetables, breakfast/ lunch etc.
- They also help us in arranging programs and participate in health camps

7. PROBLEM ENCOUNTERED:

- Although our NSS volunteers were ready for the task, convincing some of the parents was really difficult
- It was not very easy to reach out to the villagers as they didn't want to change their mindset
- Convincing the people about the need to send their children for higher education was again difficult
- Educating the people regarding the use of toilets

7.3 Institutional Distinctiveness

7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

EMPOWERMENT OF GIRLS

1. CONTEXT:

The Institutional distinctiveness lies in working towards fulfilling its vision and mission. Being a Women's College we focus on the holistic development of our students.

Our College is the only higher educational institution in the Eastern part of Solapur. We have students coming from the economically deprived strata of the society. Majority of our students come from families where the parents earn a livelihood by working as laborers, or in textile mills, while the women are involved in rolling beedis.

2. PRACTICE:

A large number of our students are not even in a position to pay their fees, buy books and meet other basic necessities. Keeping in view the financial condition of our students, we decided to empower them by making them financially independent.

Keeping in mind the global scenario, cut throat competition, need to be financially secure and the need to lead a comfortable life; we decided to train our students in small scale business and startups

3. PROCEDURE:

We made a survey of our student's economic and social background. A number of meetings were organized to which the students were called and asked to interact. We realized the need to empower our girls and make them financially stable. We got in touch with a number of organizations and people who would help in our endeavor. For this purpose we got into a Memorandum of Understanding with

- Baheti Medical and Pharma
- Udyogvardini Sanstha
- GTT Foundation
- MITCON
- Sneha Beauty Parlour
- G. L. Kakade Foundation
- Shakuntala Udyog Vyavasay Kendra
- Skill India

4. COURSES STARTED:

Following courses were started for the benefit of the students.

a) Beauty Parlour Course: The Beauty and Wellness sector is an important industry and is growing at a fast pace. There are a number of career opportunities in this sector. At the end of the course the students

can work as Makeup artist, Hair stylist and can also set up their own business.

b) Fashion Designing: The fashion industry reflects a diverse range of social and cultural attitudes. There is a need to combine fashion with creativity, imagination and natural beauty in order to create costumes and other lifestyle items. At the end of the course students can find jobs in fashion industry, manufacturing units, start their own business and sell products in the market.

c) Small Scale Industry Training Programs:

During these sessions the students are trained to make a number of products like jam, jelly, sauce, cakes, ice-creams, Pheneols, lotions, detergent soaps and powder, agarbattis, chalk, soft toys, flower vase, curtains, cushions covers, decorative pieces, napkin bouquets, jowarrotis, groundnut chutney etc.

This small scale industry training program provides the students with potential for employment with less capital requirement. There is also an opportunity for entrepreneurship and contribution to exports.

5. OUTCOME:

Many of our students have started their own business and thus are financially independent. We have helped our students get placed at various units like

- Samruddhi Beauty Parlour
- Ajanta Beauty Parlour
- Yashashree Fashion Institute
- Jain Bakery
- Puff and Pastry (Bakery)
- Bhagwan Caterers
- Annapurna Caterers

6. PROBLEMS ENCOUNTERED:

- Most of the times convincing the parents about the advantages of enrolling in such career oriented courses is a big challenge

- As these courses are conducted after college hours it becomes difficult for the students to stay back for more hours

- Although all the courses are free for the students, they need some capital to purchase raw material and begin with initially. Sometimes they are not able to even make arrangements for the same

- Transformation in some cases also is a problem

CONCLUSION: However, inspite of all these challenges, we are happy to state that the responses of our students to such courses are encouraging and many of them have been employed after the same. A few have also started their own business.
